Institutional Architecture

- **Output:** The Council issues Mandates that define the "what is" and "what will be" under current conditions. These Mandates form the factual basis for all policy proposals by the Hand of Praxis.

II. The Hand of Praxis (The Executive Branch)

The Hand of Praxis is the executive branch, mandated by the **Hand of Purpose** and the **Breath of Life**. Its sole function is to design and execute policies that efficiently move the system from the current state (defined by the Council of Aletheia) toward defined societal goals.
